## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("Trademark Assignment"), dated as of June 17, 2013, is made by SPX Corporation, a corporation established and existing under the laws of Delaware ("Assignor"), in favor of Dielectric, LLC, a Maine limited liability company ("Assignee"), the Assignee of certain assets of Assignor pursuant to a Purchase Agreement among Assignee, Sinclair Television Group, Inc., a Maryland corporation and Assignor, dated as of June 17, 2013 (the "Purchase Agreement").

**WHEREAS**, Assignor owns the entire right, title and interest in and to the trademarks and trademark registrations set forth on Schedule A (hereinafter "Trademarks"); and

**WHEREAS**, under the terms of the Purchase Agreement, Assignor has conveyed, transferred and assigned to Assignee, among other assets, the Trademarks, and has agreed to execute and deliver this Trademark Assignment, for recording with governmental authorities worldwide, including, but not limited to, the United States Patent and Trademark Office.

**NOW, THEREFORE**, the parties agree as follows:

1. Assignment. In consideration for the execution of the Purchase Agreement, the payment of the consideration stipulated in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency are hereby acknowledged, Assignor hereby conveys, transfers and assigns to Assignee subject to any existing trademark license agreements, and Assignee hereby accepts, all of Assignor's right, title and interest in and throughout the world in and to the Trademarks (including any common law rights that may exist and are associated therewith), together with the whole of the goodwill of the business pertaining thereto, the same and the rights of the Assignor to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives; together with all income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages by reason of past infringement of the Assignor's Trademarks with the right to sue for and collect the same for its own use and benefit, and for the use and on behalf of its successors, assigns or other legal representatives;
2. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Trademark Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.
3. Successors and Assigns. This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

**IN TESTIMONY WHEREOF**, Assignor has caused the aforesaid Trademarks to be assigned by its duly authorized officer.








