**CONFIRMATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**  
**SOUTHWEST FINANCIAL SERVICES, LTD.**

This Confirmation of Security Interest in Intellectual Property (this “**Agreement**”) dated May 21, 2015 is made by Southwest Financial Services, Ltd., a limited liability company organized pursuant to the laws of the state of Ohio (together with its successors and assigns, the “**Grantor**”).

**WHEREAS**, the Grantor owns the intellectual property set forth in Exhibit A hereto, the registrations and applications for the intellectual property identified therein and any claims, rights and underlying goodwill associated with such intellectual property (collectively, the “**Intellectual Property**”); and

**WHEREAS**, the Grantor has executed an amended and restated security agreement dated as of the date hereof (as amended, modified, supplemented, extended, renewed, restated or replaced, the “**General Security Agreement**”) in favour of Bank of Montreal and Bank of Montreal, Chicago Branch (together with their respective successors and assigns, collectively, the “**Lender**”), pursuant to which the Grantor granted to the Lender a security interest in and to its property, including the Intellectual Property, and any products or proceeds thereof.

**NOW THEREFORE**, for other good and valuable consideration, and in accordance with the terms and obligations set forth in the General Security Agreement, the Grantor confirms the grant to the Lender of a security interest in and to the Intellectual Property and authorizes and requests that the Register of Copyrights, the Commissioner of Patents and Trademarks and any other applicable government officer record this Agreement.

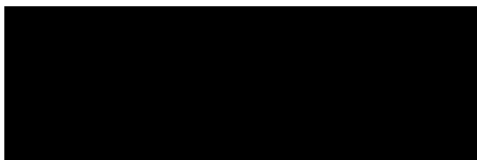

The Grantor hereby acknowledges and confirms that the grant of the security interest hereunder to, and the rights and remedies of, the Lender with respect to the Collateral (as defined in the General Security Agreement) are more fully set forth in the General Security Agreement, the terms and provisions of which are incorporated herein by reference, *mutatis mutandis*, as if fully set forth herein.


