RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”), dated as of May 21, 2015 (the “Effective Date”), is made by Bank of America, N.A., as administrative agent (in such capacity, the “Administrative Agent”), in favor of Kofax Inc., a Delaware corporation (“Kofax”), Atalasoftware, Inc., a Massachusetts corporation (“Atalasoftware”) and Kapow Technologies, Inc., a Delaware corporation (“Kapow”, and together with Kofax and Atalasoftware, the “Grantors”).

Reference is made to (i) that certain Trademark Security Agreement, dated as of August 11, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the “Initial Trademark Security Agreement”), between the Administrative Agent and Kofax, (ii) that certain Trademark Security Agreement No. 2, dated as of October 14, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “2013 Trademark Security Agreement”), between the Administrative Agent and Kofax, and (iii) that certain Trademark Security Agreement, dated as of December 23, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “Kapow Trademark Security Agreement”, and together with the Initial Trademark Security Agreement and the 2013 Trademark Security Agreement, the “Trademark Security Agreements”), among the Administrative Agent, Kapow and Atalasoftware.

Pursuant to the Trademark Security Agreements, the Grantors pledged and granted to the Administrative Agent (for and on behalf of the Secured Parties) security interests in the Trademark Collateral, including without limitation the trademarks described on Schedule I attached hereto (the “Specified Trademarks”).

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in each Trademark Security Agreement.
2. Release. The Administrative Agent hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the Specified Trademarks.
3. Recordation. The Administrative Agent hereby authorizes the Grantors, or the Grantors’ authorized representatives, to record this Release with the USPTO and corresponding offices in other countries of the world.
4. Further Assurances. The Administrative Agent agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by each Grantor, at the relevant Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.


