**WHEREAS**, Assignee desires to acquire all of Assignor's right, title and interest, in and to the Marks together with all the goodwill of the business symbolized thereby.





3. **Successors.** This Assignment of Trademarks is binding on the Assignor and its respective successors, assigns, and any principals or administrators responsible for winding down the operation of Assignor or its successors, which inures to the benefit of the Assignee and its successors and assigns.
