NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

1. Assignor hereby transfers and assigns to Assignee its entire right, title and interest in and to the Sugar Shine Intellectual Property and the Minor Case Intellectual Property, as the successor to the business or that portion of the business to which the Minor Case Intellectual Property pertains, in each case free and clear of all mortgages, liens, security interests, pledges and encumbrances, together with the goodwill associated with each of them, and including without limitation, the right to sue for past infringement.

2. This Assignment shall inure to the benefit of, and be binding upon the parties, their successors and assigns.
