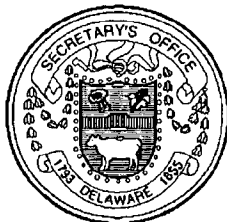


1. The Company filed its original certificate of incorporation with the Secretary of State of the State of Delaware and was first incorporated on December 27, 2010 in the State of Delaware.
