MAGISTRATE'S DECISION

This matter has come before the Court for scheduled hearing on May 12, 2015 upon the Application for Change of Name of Denise Thea Merino, an adult female. The Applicant personally appeared, was sworn, and testified. No one appeared in opposition to the Application.

Upon the evidence presented, I **FIND** that (1) the Applicant was on the date of filing of the Application a 64-year-old adult; (2) the Applicant is, and has been, for a period of at least one year prior to the filing of the Application a bona fide resident of Delaware County, Ohio; (3) proper notice of the Application was published in a newspaper of general circulation in Delaware County, Ohio on March 21, 2015, at least 30 days prior the date of this hearing; (4) Denise Thea Merino was born on February 6, 1951 in Columbus, Franklin County, Ohio with the birth name of Denise Kontras; (5) the Applicant married David Alan Merino in 1973 in Columbus, Ohio and the marriage ended by divorce in Franklin County, Ohio on November 3, 2000; (6) the Applicant has commonly used the middle name of "Thea" (an abbreviation of her mother's given name of "Theodora"), although it is not part of her legal birth name; and (7) the testimony establishes that there is reasonable and proper cause for changing the Applicant's name,



to wit: to adopt the abbreviation of her mother's given name as her middle name, and to be restored to her maiden surname.

Furthermore, I FIND that the Applicant (a) has not been convicted of, been adjudicated a delinquent child for, or pled guilty to identify fraud, and (b) does not have a duty to comply with Ohio's Sexual Offender Registration and Notification (SORN) Law. There is no legal impediment to granting the requested change of name.

I therefore CONCLUDE that the name of Denise Thea Merino, fka Denise Kontras, should be changed to Denise Thea Kontras.


