WHEREAS the Assignor desires to confirm having assigned all of its right, title, and interest in and to the Marks to the Assignee.



This assignment may be executed in separate counterparts, each of which is deemed to be an original and all of which taken together constitute one and the same agreement.


This assignment is subject to all of the terms and conditions of the Purchase Agreement. The parties intend that this assignment is for recordation purposes only.
