TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement") is made by and between Already LLC, a limited liability company ("Assignor"), and JMAN2 Enterprises LLC, a Texas limited liability company (the "Company").

WITNESSETH:

WHEREAS, Assignor has adopted and used the trademarks "Johnny Golf," "Johnny Basketball," "Johnny Soccer," "Johnny Baseball," and "Johnny Sports" listed on Exhibit A to this Agreement (the "Marks"); and

WHEREAS, in return for an assignment of the Marks, the Company agrees to maintain registrations for the Marks, and take over enforcing the Marks; and

WHEREAS, Assignor has agreed to assign and the Company has agreed to acquire all of Assignor's right, title, and interest in and to the Marks, both registered and common law, the goodwill of the business symbolized thereby and associated therewith, and the right to recover damages and profits for past infringement thereof; and

NOW, THEREFORE, in consideration of these premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers, and conveys unto the Company all of Assignor's right, title, and interest in and to the Marks, both registered and common law, the goodwill of the business symbolized thereby and associated therewith, and the right to recover damages and profits for past infringement thereof.

2. This Agreement shall be governed by and construed in accordance with the laws of the United States of America and of the State of Texas.
