GRANT OF SECURITY INTEREST
TRADEMARKS

THIS GRANT OF SECURITY INTEREST, dated as of May 13, 2015, is executed by SAVINGSTAR, INC., a Delaware corporation with an address of 400 Totten Pond Road, Suite 300, Waltham, Massachusetts 02451 ("Debtor"), in favor of HORIZON TECHNOLOGY FINANCE CORPORATION, a Delaware corporation with an address of 312 Farmington Avenue, Farmington, Connecticut 06032 ("Secured Party").

A. Pursuant to a certain Venture Loan and Security Agreement, dated as of the date hereof (the "Agreement") by and between Debtor and the Secured Party, the Secured Party has agreed to extend certain credit facilities to Debtor upon the terms and subject to the conditions set forth therein;

B. Debtor owns the trademarks and service marks (and applications and registrations therefor), of the United States, as more particularly described on Schedules 1 annexed hereto as part hereof (collectively, the "Trademarks");

C. Pursuant and subject to the Agreement, Debtor has granted to Secured Party a security interest in all right, title and interest of Debtor in and to the Trademarks, together with all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof and all in each case the goodwill associated therewith (the "Collateral"), to secure the prompt payment, performance and observance of the Obligations (as defined in the Agreement);

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor does hereby grant to Secured Party a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the security interest in the Collateral granted hereby are more fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

This Grant and all obligations of the Secured Party under the Agreement shall terminate on the date upon which the Obligations have been fully satisfied without delivery of any instrument or performance of any act by any party to the Agreement. Upon termination of the Agreement, the Secured Party shall take such actions as reasonably may be necessary to release its security interest in the Collateral.
