

Assignor irrevocably designates and appoints Assignee and its duly authorized officers, members, assignees, affiliates and employees and agents as its agent and attorney-in-fact to execute and file any and all applications and other necessary documents and to do all other lawfully permitted acts to further the prosecution, issuance or enforcement of the Assigned Trademarks with the same legal force and effect as if Assignor had executed them. The laws of the United States shall govern the interpretation and enforcement of this Agreement.


