

# CERTIFICATE OF AMENDMENT OF THE CERTIFICATE OF INCORPORATION OF NEXT STEP PUBLISHING, INC.

## **Under Section 805 of the Business Corporation Law**

The undersigned, being the President of Next Step Publishing, Inc., does hereby set forth:

- 1. The name of the Corporation is Next Step Publishing, Inc..
- 2. The Certificate of Incorporation of the Corporation was filed by the Department of State on June 26, 1995 under the name "The Next Step Magazine, Inc."
- 3. The Certificate of Incorporation is hereby amended to effect the following amendments authorized by the Business Corporation Law:
  - (a) to change the name of the Corporation;
- (b) to delete in its entirety Article 2 regarding the purpose of the Corporation and to add new Article 2 restating the purpose of the Corporation.
- 4. To effectuate the foregoing, paragraph "1" of the Certificate of Incorporation is hereby amended in its entirety to read as follows:
  - "1. The name of the Corporation is Next Step Education Group, Inc."
- 5. To effectuate the foregoing, paragraph "2" of the Certificate of Incorporation is hereby amended in its entirety to read as follows:
  - "2. The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Business Corporation Law of the State of New York. In particular, the primary purpose of the Corporation is to provide information on life skills in the areas of financial literacy, interviewing skills, entrepreneurship, nutrition, goal setting and time management. The Corporation is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body, without such consent or approval first being obtained. Nothing herein shall authorize the corporation to operate, maintain or manage a charter school, a nursery school, an elementary school, a secondary school, a college, university or to advertise or offer credit-bearing courses or degrees in New York State. Nothing herein shall authorize the corporation to operate or maintain a library, museum, archive or historical society or to own or hold collections. Except as authorized by Title VIII or other applicable statute, nothing herein shall authorize the corporation to engage in the practice of any profession in New

York or to use a professional title or term of any profession in New York in violation of Title VIII of the Education Law.

The corporation will restrict the provision of counseling services to instruction, advice, support, encouragement or information to individuals, families, and relational groups, provided that this shall not include the diagnosis or treatment of mental, emotional, nervous, or behavioral disorders. Nothing herein shall authorize the corporation, directly or indirectly, to own, operate, or maintain a public television and/or public radio station pursuant to Section 236 of the Education Law nor to request funding as such.

This Amendment of the Certificate of Incorporation as set forth herein was duly and properly authorized by unanimous written consent of the directors followed by the unanimous written consent of the shareholders of the Corporation.
