ASSIGNMENT OF TRADEMARK COLLATERAL AGREEMENT

This Assignment of Trademark Collateral Agreement ("Assignment") is executed as of May 29, 2015, by Bank of Montreal, a Canadian chartered bank ("Assignor"), in its capacity as owner of a security interest in and to the assets set forth in Schedule A granted by Lot 26 Studio, Inc., a California corporation ("Debtor"), in favor of Artissimo Designs LLC, a Delaware limited liability company ("Assignee").

Assignor and Assignee, in consideration of ten (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, do hereby agree as follows:

Assignor assigns, quitclaims and conveys to Assignee all of Assignor's right, title and interest in, to, and under that Trademark Collateral Agreement dated May 24, 2011, which was executed by Debtor in favor of Assignor and recorded at Reel / Frame No. 4546 / 0704 at the United States Patent and Trademark Office (the "Trademark Security Agreement"). The Trademark Security Agreement granted to Assignor certain security interests in and to the trademarks described in Schedule A attached hereto, together with the goodwill associated therewith and all registrations, recordings and renewals thereof, and all applications in connection therewith, issued by or filed in a national, state or local governmental authority of any country.

This Assignment is made pursuant to that Assignment of Debt and Security (the "Assignment Agreement") having the same date as this Assignment, and executed by Assignor and Assignee. This Assignment is made without recourse to the Assignor and without any representations or warranties made by the Assignor but the foregoing shall not affect the applicable warranties or representations set forth in Section 8 of the Assignment Agreement.

This Assignment shall inure to the benefit of the successors and assigns of Assignee.
