**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE (this "Release"), dated as of June 1, 2015, by Bank of America, N.A., in its capacity as administrative agent (in such capacity, "Administrative Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreements (as defined below).

WITNESSETH:

WHEREAS, (i) Wendy's International, LLC (f/k/a Wendy's International, Inc.) and Oldemark LLC (each individually a "Pledgor", and, collectively, the "Pledgors") and Administrative Agent were parties to that certain Security Agreement dated as of May 15, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), (ii) Pledgors and Administrative Agent were parties to that certain Trademark Security Agreement dated as of May 15, 2012 (the "TSA"), (iii) Oldemark LLC and Administrative Agent were parties to that certain Supplemental Trademark Security Agreement dated as of March 29, 2013 (the "Supplemental TSA"), (iv) Oldemark LLC and Administrative Agent were parties to that certain Second Supplemental Trademark Security Agreement dated as of September 5, 2013 (the "Second Supplemental TSA") and (v) Oldemark LLC and Administrative Agent were parties to that certain Third Supplemental Trademark Security Agreement dated as of January 27, 2014 (the "Third Supplemental TSA"; and together with the Security Agreement, TSA, Supplemental TSA and Second Supplemental TSA, collectively, the "Security Agreements"), pursuant to which each Pledgor, as applicable, pledged and granted to the Administrative Agent a lien on and security interest in and to all of its right, title and interest in, to and under certain Pledged Collateral of such Pledgor, including the Pledged Collateral set forth on Schedule I hereto;

WHEREAS, (i) the TSA was recorded by the Trademark Division of the United States Patent and Trademark Office on May 17, 2012, at Reel 4781, Frame 0962, (ii) the Supplemental TSA was recorded by the Trademark Division of the United States Patent and Trademark Office on April 1, 2013, at Reel 4995, Frame 0049, (iii) the Second Supplemental TSA was recorded by the Trademark Division of the United States Patent and Trademark Office on September 5, 2013, at Reel 5105, Frame 0915 and (iv) the Third Supplemental TSA was recorded by the Trademark Division of the United States Patent and Trademark Office on January 27, 2014, at Reel 5202, Frame 0082; and

WHEREAS, each Pledgor has requested that Administrative Agent release its security interest in the Pledged Collateral and reassign any and all rights in the same to the applicable Pledgor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases, relinquishes and discharges its Lien on and security interest in and to all of each Pledgor's right, title and interest in, to and under the Pledged Collateral of such Pledgor, including but not limited to, the following:

(a) Trademarks of such Pledgor listed on Schedule I attached hereto (other than any intent-to-use trademark application to the extent and for so long as creation by a Pledgor of a security interest therein would result in the loss by such Pledgor of any material rights therein);

(b) all Goodwill associated with such Trademarks; and

(c) all Proceeds of any and all of the foregoing (other than Excluded Property).

2. Administrative Agent hereby reassigns, grants and conveys to each Pledgor, as applicable, without any representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent's right, title and interest in, to and under the Pledged Collateral.

3. The Administrative Agent hereby agrees to take all further actions, and provide to each Pledgor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Pledgor, at such Pledgor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

4. The Administrative Agent hereby authorizes any Pledgor or any Pledgor's authorized representative to (i) record this Release with the U.S. Patent and Trademark Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the Administrative Agent's security interest in the Pledged Collateral and (iii) otherwise record or file this Release in the applicable governmental office or agency.

5. This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


