CERTIFICATE OF INCORPORATION

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said corporation, by the unanimous written consent of its members filed with the minutes of the Board, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

RESOLVED, that the Certificate of Incorporation of UGSI ChemFeed, Inc. be amended by changing the First Article thereof so that, as amended, said Article shall be and read as follows:
