TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "**Termination**"), is dated as of June 1, 2015, and made by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as Agent under the below-defined Security Agreement, having an office at 500 First Avenue, Commercial Loan Service Center/DCC, Pittsburgh, PA 15219 ("**Grantee**") to **BRIDGE TERMINAL TRANSPORT SERVICES, INC.**, a Delaware corporation ("**Grantor**"), with an address at 9140 Arrowpoint Boulevard, Suite 300, Charlotte, NC 28273.

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of September 3, 2013, made by Grantor in favor of Grantee (the "**Security Agreement**"), a security interest was granted by Grantor to Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on September 4, 2013, at Reel 5103 and Frame 0469; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. **Definitions.** The term "Trademark Collateral," as used herein, shall mean and include all of Grantor's right, title and interest of every kind and nature as of the date hereof in, to and under the following: (a) all of Grantors' trademarks, trademark applications, service marks, trade names, mask works and associated goodwill (collectively, "**Trademarks**"), including those referred to on Schedule A hereto, and licenses for any of the foregoing ("**Licenses**"); (b) all reissues, continuations, continuations-in-part, substitutes, extensions or renewals of and improvements on the foregoing; and (c) all products and proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future infringement or dilution of any Trademark or any Trademark licensed under any License.

2. **Release of Security Interest.** Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral. Grantee hereby authorizes Grantor and/or Grantor's agents, representatives or designees, to record this Termination and Release of Trademark Security Agreement with the United States Patent and Trademark Office.
