RELEASE OF LIEN AND SECURITY INTEREST - TRADEMARKS

WHEREAS, FUHU, Inc., a California corporation (“Fuhu”) and Boardwalk Capital Holdings Limited, a British Virgin Islands company (“Boardwalk Capital”) are or were parties to a certain Secured Convertible Note Purchase Agreement dated October 6, 2008 (“Note Purchase Agreement”) as well as a certain Security Agreement of even date thereto (“Security Agreement”);

WHEREAS, all capitalized terms used but not otherwise defined herein shall have the meanings assigned to them in the Security Agreement;

WHEREAS, pursuant to the Note Purchase Agreement and Security Agreement, the latter of which was recorded in the United States Patent and Trademark Office at Reel No. 3869, Frame No. 0414 on October 10, 2008, Fuhu granted to Boardwalk Capital a Lien on and security interest in and to, inter alia, the Intellectual Property (including those trademark applications and registrations listed on Schedule A hereto);

WHEREAS, Boardwalk Capital acknowledges and agrees that all of Fuhu’s obligations with respect to the Note Purchase Agreement and the Security Agreement were and have now been fully and completely satisfied and that, pursuant to Section 10 of the Security Agreement, the Lien and security interest granted have been and hereby are terminated; and

WHEREAS, Boardwalk Capital desires to fully, completely and formally release its Lien on and security interest in and to the Intellectual Property (including in those trademark registrations listed on Schedule A hereto and in and to any and all other trademarks of Fuhu and Fuhu’s successors and successors-in-interest, including Fuhu Holdings, Inc.), and to record such release with the U.S. Patent and Trademark Office.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Boardwalk Capital does hereby fully, completely and formally re-assign, release, relinquish and discharge any Lien, security interest and any other interest it may have in the Intellectual Property (including in those trademark registrations listed on Schedule A hereto and in and to any and all other trademarks of Fuhu and Fuhu’s successors and successors-in-interest, including Fuhu Holdings, Inc.).
