RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of May 29, 2015 ("Effective Date") by and between Manufacturers and Traders Trust Company, a New York State banking corporation ("Grantee"), and Coastal Sunbelt Produce Company, a Maryland corporation ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Collateral Assignment of Trademarks As Security by and between Grantor and Grantee dated June 15, 2012 (the "Collateral Assignment of Trademarks As Security"), Grantor granted to Grantee a security interest in Grantor's Trademarks (as defined in the Collateral Assignment of Trademarks As Security), including, without limitation, the Trademarks set forth on Schedule A attached hereto;

WHEREAS, the Collateral Assignment of Trademarks As Security was recorded with the United States Patent and Trademark Office ("PTO") on June 20, 2012, at Reel 004807, Frame 0093; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Collateral Assignment of Trademarks as Security and releases Grantor from any liability or obligations that have arisen or may arise under such agreement, and hereby terminates, cancels, and releases any and all security interests it has against the Trademarks, and hereby irrevocably assigns and agrees to assign to Grantor the entire past, present and future right, title and interest in, to and under the Trademarks, together with all goodwill associated therewith, and the right (but not the obligation) to sue for past, present and future infringements, and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world.

Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, Grantor's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
