WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on March 30, 2012 at Reel 004749, Frame 0196; and


WHEREAS, Grantor has agreed to terminate and release its security interest and all of its right, title and interest in and to each of the Trademarks.


