SECOND AMENDMENT TO TRADEMARK ASSIGNMENT AGREEMENT

THIS SECOND AMENDMENT TO THE TRADEMARK ASSIGNMENT AGREEMENT (this "Amendment") is signed as of 21 April 2015 with retroactive effect as of 2 October 2014 (the "Effective Date"), by and between Parkmobile Group B.V., a private company with limited liability organized under the laws of the Netherlands, whose corporate seat is in Amsterdam, the Netherlands, registered at the Chamber of Commerce under number 34124818, ("Assignor") and Parkmobile International Holding B.V., private company with limited liability organized under the laws of the Netherlands, whose corporate seat is in Utrecht, the Netherlands, registered at the Chamber of Commerce under number 30211513 ("Assignee").



WHEREAS, Assignor and Assignee entered into a Trademark Assignment Agreement with effective date 2 October 2014 (the "Agreement"), pursuant to which Assignee, at its request and direction, has acquired, and Assignor wishes to assign all of Assignor's right, title, and interest in and to certain trademarks listed in Exhibit A to that Agreement, as well as the accompanying goodwill.









WHEREAS, Assignor and Assignee have entered into an amendment to the Agreement on 7 January 2015, with effective date 2 October 2014 pursuant to which one additional (Canadian) trademark has been included to be assigned by Assignor to Assignee.

WHEREAS, Assignor and Assignee wish to further amend the Agreement, by including certain additional trademark registrations to be assigned by Assignor to Assignee.

NOW, THEREFORE, for good and valuable consideration (including the promises and covenants set forth in the Agreement), the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

The following trademarks will be included in Exhibit A to the Agreement, and will qualify as a Trademark under the Agreement.
