TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") dated February 27, 2015 is made by Lehman Brothers Holdings Inc., a corporation duly organized and existing under the laws of the State of Delaware and having its principal place of business at 1271 Avenue of the Americas, 38th Floor, New York, New York 10020, and Setai Owners LLC, a limited liability company duly organized and existing under the laws of the State of Delaware (collectively, the "Assignors") and BPI Lux S.à.r.l. ("BPI"), a corporation duly organized and existing under the laws of the Grand Duchy of Luxembourg and having its registered office at 7A, rue Robert Stümper, L-2557 Luxembourg, and Alexandre von Furstenberg Living Trust ("Trust"), a Living Trust organized under the laws of the State of California and with an address of 14 Beverly Park, Beverly Hills, CA 90210 (collectively, the "Assignees").

WHEREAS, Assignor Lehman Brothers Holdings Inc. is the record owner of the marks set forth on Schedule A, which are currently registered or pending in the United States Patent and Trademark Office (the "Marks");

WHEREAS, Assignor Setai Owners LLC holds ownership interests in significant portions of the Setai Resort & Residences, located at 2001 Collins Avenue, Miami Beach, Florida 33139.

WHEREAS, Assignees desire to acquire any and all rights that Assignors may have in and to the Marks, and the associated registrations and applications listed on Schedule A, together with the goodwill of the business symbolized by the Marks, as well as that portion of the Assignors' business to which the Marks pertain; and

WHEREAS, Assignees have agreed that BPI shall own eighty-five percent (85%) of the Marks and that the Trust shall own fifteen percent (15%) of the Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors hereby assign and transfers to Assignees all right, title and interest in and to the Marks, and the registrations and applications listed on Schedule A, together with the goodwill of the business symbolized by the Marks, as well as that portion of the Assignors' business to which the Marks pertain;

Except as otherwise set forth in that certain Purchase and Sale Agreement, dated as of December 15, 2014, by and among Setai Owners LLC, Abbey Owners LLC, Nakash Properties, LLC and Chicago Title Insurance Company (as assigned, the "Purchase Agreement"), this Assignment is made without any covenant, warranty or representation by, or recourse against, Assignors or Sellers' Affiliates (as defined in the Purchase Agreement) of any kind whatsoever and nothing contained in this Assignment shall broaden the scope of any representations, obligations or liabilities of Assignors further to those set forth in the Purchase Agreement.


