CERTIFICATE OF MERGER

OF

SOULCYCLE IP LLC

INTO

SOULCYCLE INC.

Under Section 904-a of the Business Corporation Law

FIRST: The name of the domestic entity that is to merge is SoulCycle IP LLC; a New York limited liability company, organized under the name of Elizabeth Plamondon Cutler, LLC. (domestic LLC). The name of the foreign surviving entity is SoulCycle Inc. a Delaware corporation (foreign corporation).

SECOND: The articles of organization of the domestic LLC were filed by the Department of State on December 21, 2001.

THIRD: The initial certificate of incorporation of the foreign corporation was filed with the Secretary of State of Delaware on March 25, 2011, and an application for authority of the foreign corporation was filed with the Department of State on May 29, 2015.

FOURTH: The agreement and plan of merger has been approved and executed by each entity that is to merge.

FIFTH: The name of the surviving corporation shall be SoulCycle Inc.

SIXTH: The surviving foreign corporation agrees that it may be served with process in the State of New York in any action or special proceeding for the enforcement of any liability or obligation of the domestic entity, previously amenable to suit in the State of New York, and for the enforcement, as provided in the Business Corporation Law of the State of New York, of the right of shareholders or members of any domestic entity to receive payment for their interests against the surviving corporation.

SEVENTH: The surviving corporation hereby designates the Secretary of State of the State of New York as its agent upon whom process against it may be served in the manner set forth in paragraph (b) of section 306 of the Business Corporation Law in any action or special proceeding. The post office address within the State of New York to which the said Secretary of State shall mail a copy of any process against the surviving foreign corporation served upon him is 609 Greenwich Street, New York, NY 10014.

EIGHTH: Subject to the provisions of section 623 of the Business Corporation Law, Section 1005 of the Limited Liability Company Law, and any applicable statute, the surviving foreign corporation will promptly pay to the members the amount, if any, to which they shall be entitled under the provisions the Limited Liability Company Law or any applicable statute relating to the rights of members to receive payment for their interests.

NINTH: The effective date of the merger shall be the date of filing of the certificate of merger by the Department of State

TENTH: The agreement of merger is on file at the following place of business of the surviving foreign corporation: 609 Greenwich Street, New York, NY 10014.

ELEVENTH: The merger herein certified in respect of the merged foreign corporation is permitted by its jurisdiction of incorporation and is in compliance therewith.
