TRADEMARK ASSIGNMENT

This Trademark Assignment is entered into freely by and between Investors Capital Holdings, Ltd. ("Assignor") and Investors Capital Holdings, LLC ("Assignee") and is effective as of the 3rd day of June 2015.

WHEREAS, Assignor is the owner of the trademarks identified as follows: INVESTORS CAPITAL, U.S. Registration No. 3,066,881; and INVESTORS CAPITAL HOLDINGS, U.S. Reg. No. 3,047,858 (the "Trademarks");

WHEREAS, Assignee is the successor to Assignor by merger, as evidenced by the certificate of merger attached as Exhibit A; and

WHEREAS, Assignor now desires to assign to Assignee all right, title and interest in and to said Trademarks, together with the related goodwill, and Assignee desires to acquire from Assignor all of its right, title and interest in, and to said Trademarks, together with the related goodwill.

NOW, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers, conveys and grants to Assignee, its successors, assigns and legal representatives forever, Assignor's entire right, title and interest in and to such Trademarks throughout the world in perpetuity, together with the goodwill associated therewith and that part of the Assignor's business connected with the use thereof and symbolized thereby, and any and all of Assignor's other rights, privileges and priorities provided under state and federal law of the United States, and under the laws of any and all foreign jurisdictions with respect to the Trademarks, including without limitation, Assignor's common law rights and rights under the laws of unfair competition, and any and all rights of action at law and suits in equity to recover for past infringements of the assigned Trademarks currently known to Assignor as of the date hereof or that may become known after the date of this Agreement (the "Transferred Rights"), and any and all of Assignor's rights to obtain renewals, reissues, and extensions for such Trademarks upon registration throughout the world, or other legal protections pertaining to the Transferred Rights;

AND, Assignor hereby covenants that Assignor has the full right to convey the interest assigned by this Agreement, has not conveyed any interest in or right to the Trademarks to any third party;


AND, Assignor hereby further covenants and agrees that Assignor will, without further consideration, communicate with Assignee, its successors and assigns, any facts known to Assignor respecting the Trademarks, and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the Trademarks in said Assignee, its successors and assigns, and generally do everything possible to aid Assignee, its successors and assigns, to obtain and enforce proper trademark protection for the Trademarks in the United States and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by Assignee, its successors and assigns.


