TRADE MARK ASSIGNMENT AGREEMENT
(United States of America)

This Agreement is made the 15th day of August 2014

Between

- (1) **BP p.l.c.**, a company incorporated in England with registered number 102498, whose registered office is at 1 St James's Square, London SW1Y 4PD (the "**Assignor**"); and
- (2) **BASF SE**, a company whose registered office is at Carl-Bosch-Strasse 38, 67056 Ludwigshafen am Rhein, Germany (the "**Assignee**").

Whereas:

- (A) The Assignor is the owner of the Trade Marks.
- (B) The Assignor has agreed to assign to the Assignee all of its rights, title and interest in and to the Trade Marks upon the terms set out in this Agreement.

It is agreed as follows:

Definitions

In this Agreement "**Trade Marks**" means the registered trade marks and applications for registration listed in the Schedule to this Agreement, together with the goodwill of the business in the products for which, and to the extent only that, such trade marks are used.

1 Assignment

In consideration of the sum of ten Euro (10€), receipt of which is acknowledged, the Assignor hereby assigns to the Assignee all of its rights, title and interest in and to the Trade Marks, including without limitation:

- 1.1** all rights of action, powers and benefits in respect of the Trade Marks; and
- 1.2** the right to seek and recover damages and all other remedies for any past infringement of the Trade Marks.

2 Recordal of Assignment

The Assignee shall, at its own expense and as soon as reasonably practicable following execution of this Agreement, take all such steps and do all such things as are necessary to record the assignment of the Trade Marks to the Assignee on the relevant trade mark register.

3 Further Assurance


The Assignor shall at its own expense, execute all documents and do all such acts and things as may be reasonably requested by the Assignee in order to give legal effect to the assignment of the Trade Marks to the Assignee and the recordal thereof.
