IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 29, 2015 ("Release"), is made by Laminar Direct Capital, L.L.C (formerly known as Laminar Direct L.P.) as Agent and Laminar Direct Capital, L.L.C. (formerly known as Laminar Direct Capital L. P.) as Control Agent (collectively, the "Agents") in favor of Redfish Rentals Inc. ("Grantor").

WHEREAS, pursuant to that certain First Lien Security and Pledge Agreement dated as of July 31, 2006 (as amended, modified, extended, or restated from time to time, the "Security Agreement") by and among the Obligor party thereto (each an "Obligor" and collectively the "Obligors") and the Agents, each Obligor granted to the Agents, for the benefit of the Lenders, a continuing security interest in, and a right to set off against, any and all right, title and interest of such Obligor in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing;

WHEREAS, pursuant to the Security Agreement, Grantor, an Obligor, executed and delivered to Agents, for the benefit of the Lenders, the Notice of Grant of Security Interest in Trademarks dated as of July 31, 2006 ("Notice"); and

WHEREAS, the Notice was recorded at the United States Patent and Trademark Office ("USPTO") on November 29, 2012 at Reel 4909 Frame 0732.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, the Agents, on behalf of the Lenders, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. The Agents, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the Grantor's right, title, and interest in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing, including, but not limited to, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
