TRADEMARK ASSIGNMENT AGREEMENT




4. This Agreement will be binding on and inure to the benefit of the Parties and their affiliates, subsidiaries, related companies, successors and assigns and all others acting by, through, or with them or under their direction or in privity with them.

5. A facsimile or photocopy signature of an authorized agent of Assignor shall be sufficient for all purposes.
