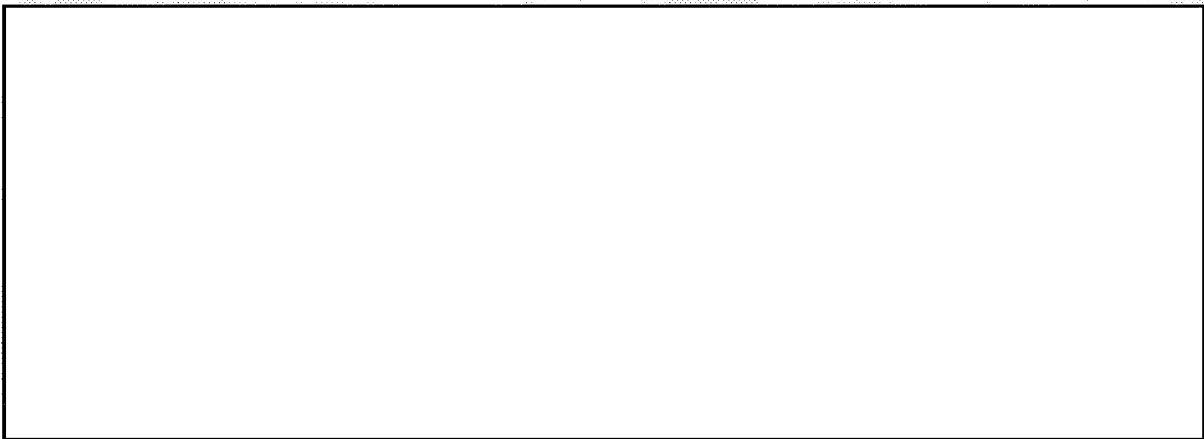

TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Agreement") is made by and between Ted Chao and Jane Zheng, individuals domiciled in California ("Assignors"), and KF Tea USA Inc, a New York corporation having its principal office at 34-36 56th Street, Woodside, New York 11377 ("Assignee").

WHEREAS, Assignors are the owners of the one or more trademarks or service marks comprising the English letters "KUNG FU ENERGY" used in conjunction with the goods or services of tea beverages ("KFE Mark") and U.S. Registration No. 4019619 for the KFE Mark, which covers "beverages with a tea base" in Class 030 ("KFE Registration");

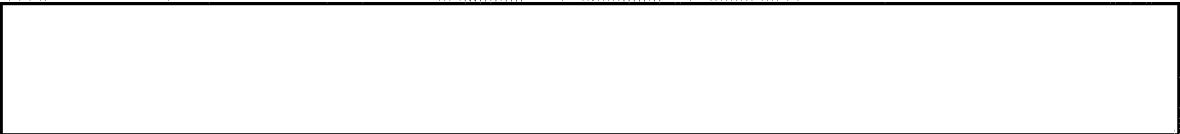


NOW THEREFORE, in consideration of the mutual terms, covenants and conditions contained in this Agreement, and other good and valuable consideration, the Parties agree as follows:

Assignment of the KFE Mark: Assignors hereby assign, grant and transfer to Assignee all rights, titles, and interests in and to the KFE Mark in all goods and services applicable, including, but not limited to, the KFE Registration and all common law rights, together with the goodwill of the business represented by the KFE Mark, throughout the world.
