NOW, THEREFORE, for and in consideration of the foregoing premises and Ten Dollars (\$10.00) in hand paid and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers unto Assignee, its successors, assigns and legal representatives, the entire right, title and interest in and to the Trademarks including domestic and foreign rights, including without limitation: (i) all good will symbolized by and associated with the Trademarks; (ii) any and all applications, registrations or certificates or renewals that may be pending, issued or granted therefor; (iii) all income, royalties, damages or other remedies and payments now or hereafter due or payable in respect to the Trademarks; (iv) all causes of action, either in law or in equity, for damages for past, present or future infringement of the Trademarks, throughout the entire world; and (v) the right to file and prosecute applications and/or renewals and obtain registrations of the Trademarks in Assignee's own name throughout the world, including, without limitation, all rights of priority.


