ARTICLES OF CONVERSION

WA SECRETARY OF STATE

Pursuant to the provisions of Section 23B.09.040 of the Revised Code of Washington (the "RCW"), DocuSign, Inc., a Washington corporation (the "Converting Entity") and DocuSign, Inc., a Delaware corporation (the "Surviving Entity"), hereby authorize for filing with the Secretary of State of the State of Washington the following Articles of Conversion:

1. The Converting Entity has been converted into the Surviving Entity (the "Conversion").
2. The name and form of the Converting Entity and the jurisdiction of its governing statute are as follows:

DocuSign, Inc., a corporation organized under the laws of the State of Washington, governed by the Washington Business Corporation Act.
3. The name and form of the Surviving Entity and the jurisdiction of its governing statute are as follows:

DocuSign, Inc., a corporation organized under the laws of the State of Delaware, which will be governed by the Delaware General Corporation Law (the "DGCL").
4. Pursuant to Sections 265 and 103(d) of the DGCL, the Conversion was effective upon the filing of the Certificate of Conversion and Certificate of Incorporation of the Surviving Entity with the Secretary of State of the State of Delaware, which filings were made simultaneously on March 11, 2015.
5. The Conversion has been duly approved as required by RCW Chapter 23B.09.030.
6. The Conversion has been duly approved as required by the governing statute of the Surviving Entity.

RESTATED CERTIFICATE OF INCORPORATION

OF

DOCUSIGN, INC.

DocuSign, Inc. (the "*Corporation*"), a corporation organized and existing under the General Corporation Law of the State of Delaware (the "*DGCL*"), by its duly authorized officer, does hereby certify that:

1. The original name of the Corporation was DocuSign Delaware, Inc. and the date of filing of the original Certificate of Incorporation of the Corporation with the Secretary of State of the State of Delaware was March 17, 2015.

2. Pursuant to the applicable provisions of Sections 228, 242 and 245 of the DGCL, this Restated Certificate of Incorporation was adopted by the Corporation's Board of Directors.

ARTICLE I

The name of this corporation is DocuSign, Inc.

ARTICLE II

The address of the registered office of the Corporation in the State of Delaware is 2711 Centerville Road, Suite 400, City of Wilmington, County of New Castle, Delaware 19808. The name of the registered agent of the Corporation at such registered office is Corporation Service Company.

ARTICLE III

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the DGCL.

ARTICLE IV

(A) **Classes of Stock.** The Corporation is authorized to issue two classes of stock to be designated, respectively, "*Common Stock*" and "*Preferred Stock*." The total number of shares that the Corporation is authorized to issue is 224,367,215. 140,000,000 shares shall be Common Stock and 84,367,215 shares shall be Preferred Stock. The Preferred Stock shall have a par value of \$0.0001 per share and the Common Stock shall have a par value of \$0.0001 per share. The number of authorized shares of Common Stock may be increased or decreased (but not below the number of shares of Common Stock then outstanding) by the affirmative vote of the holders of a majority of the stock of the Company entitled to vote (voting together as a single class on an as-if-converted basis).

(B) **Rights, Preferences and Restrictions of Preferred Stock.** The Preferred Stock authorized by this Restated Certificate of Incorporation (this "*Certificate*") may be issued from
