## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "**Trademark Assignment**"), dated as of May 31, 2015, is made by LAKES MERGER SUB LLC, a Missouri limited liability company with an address of 1010 Grand Boulevard, Kansas City, MO 64106 ("**Assignor**") in favor of UMB FINANCIAL CORPORATION, a Missouri corporation with an address of 1010 Grand Boulevard, Kansas City, MO 64106 ("**Assignee**")

1. Assignment. Assignor hereby assigns, transfers and conveys to Assignee, its successors and assigns, (a) all of the present and future right, title and interest to the trademarks identified on Appendix A attached hereto (the "Trademarks"), together with the goodwill of the business associated with and symbolized by the Trademarks, (b) all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any of the Trademarks, and (c) the right to sue and obtain any remedies in law or equity for past, present or future infringement, dilution, unfair competition and counterfeiting of the Trademarks or any goodwill attaching to the foregoing, and the right to collect all damages, profits, settlements and proceeds for any such infringement, dilution, unfair competition and counterfeiting of the Trademarks for its own use and benefits.
2. Recordation and Further Actions. Assignor authorizes the Commissioner for Trademarks and any other governmental officials to record and register this Trademark Assignment upon request by Assignee. Upon the request of Assignee or its designee, Assignor shall take such steps and actions following the date hereof, including, without limitation, the execution of any documents, files, registrations, or other similar items, to ensure that the Trademarks are properly assigned to Assignee, or any assignee or successor thereto.
3. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Trademark Assignment delivered by email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.
4. Successors and Assigns. This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
5. Governing Law. The execution, interpretation, and performance of this Trademark Assignment shall be governed by the laws of the State of Missouri without giving effect to any conflict-of-laws provision or rule (whether of the State of Missouri or any other jurisdiction) that would cause the application of the law of any other jurisdiction other than the State of Missouri.
