WHEREAS, PWIT LLC, ("Assignee"), a limited liability company organized under the laws of the State of New York, having a business address of 9 Sophie Court, Commack, New York 11725, is desirous of acquiring said Trademarks and registrations (hereinafter collectively referred to as "Trademarks");

WHEREAS, Smokin' Al's, Inc., filed a voluntary petition for relief pursuant to Chapter 11 of the Bankruptcy Code on June 1, 2012, in the United States Bankruptcy Court, Eastern District of New York;

WHEREAS, by order of the Bankruptcy Court dated March 18, 2013, Smokin' Al's, Inc., was converted from a case under Chapter 11 of the Bankruptcy Code to one under Chapter 7 of the Bankruptcy Code;

WHEREAS, by Notice of Appointment dated March 13, 2013, Richard L. Stern was appointed as the Interim Trustee of the Estate of Smokin' Al's, Inc. and thereafter did duly qualify as the permanent Trustee in that case (the "Trustee") and the aforesaid Trademarks became assets of the aforementioned Estate;

WHEREAS, Richard L. Stern as Trustee of the Estate of Smokin' Al's, Inc. ("Assignor"), pursuant to a stipulation and an entry of a final order by the Bankruptcy Court approving the Stipulation by the Bankruptcy Court, was authorized to convey to PWIT LLC said Trademarks pursuant to said approved stipulations;

WHEREAS, Richard L. Stern as Trustee of the Estate of Smokin Al's, Inc. was also authorized upon the entry of a Final Order approving this Stipulation, to execute those documents that are necessary to convey the Smokin' Al's, Inc.'s estate's interest in the Trademarks to the Assignee to enable the Assignee to record its ownership interest in the Trademarks.

NOW, THEREFORE, in consideration of the sum of \$10.00 and/or other good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby assigns

to Assignee, all right, title and interest in and to said marks and the aforesaid registrations thereof, together with the goodwill of the business connected with the use of and symbolized by said marks, as fully and entirely as the same would have been held and enjoyed by Assignor, if this assignment had not been made, together with all claims for damages by reason of past infringement of said marks, with the right to sue for and collect the same for its own use and enjoyment, and for use and enjoyment of its successors, assigns, or other legal representatives.
