RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT ("Agreement") made as of the 11th day of June, 2015, by MIDCAP FINANCIAL TRUST (FKA MIDCAP FINANCIAL, LLC) ("Lender"), in favor of URGENT CARES OF AMERICA HOLDINGS, LLC, a Delaware limited liability company ("Company"). Capitalized terms not otherwise defined herein have the meaning set forth in the Security Agreement (as defined below).

RECITALS

WHEREAS, Company granted to Lender a continuing security interest in Company's entire right, title and interest in and to the following (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"), whether now owned or existing and hereafter created, acquired or arising (a) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and (b) all products and proceeds of the forgoing, including without limitation, any claim by Company against third parties for past, present or future (i) infringement or dilution of any Trademark, or (ii) injury to the goodwill associated with any Trademark, pursuant to a Trademark Security Agreement dated as of March 31, 2014 ("Security Agreement"), and recorded on April 1, 2014, with the United States Patent and Trademark Office at Reel/Frame No. 5248/0415.

WHEREAS, Company has no outstanding obligations to Lender under the terms of the Security Agreement, and Lender agrees to release in full its security interest in the Trademark Collateral.


AGREEMENT


