TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of June 12, 2015 by MARANON CAPITAL, L.P., as Agent for the Lenders ("**Agent**").

WITNESSETH:

WHEREAS, Agent and Emergency Communications Network, LLC, a Delaware limited liability company ("**Grantor**"), were parties to that certain Trademark Security Agreement dated as of October 3, 2011 (the "**Security Agreement**"), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the "**Trademarks**") and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on October 12, 2011 at Reel 4640, Frame 0119; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on the Trademarks and Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases and discharges fully its security interest in and lien on all of Grantor's right, title and interest in, to and under the following (collectively, the "**Trademark Collateral**"): .

(i) all of the Grantor's Trademarks, including those referred to on Schedule 1 attached hereto;

(ii) all renewals and extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(iv) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark or (b) injury to the goodwill associated with any Trademark.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademark Collateral.

3. Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Trademark Release.

4. Agent shall take all further actions and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Trademark Release, at Grantor's sole expense, and without representation or warranty by Agent.

5. This Trademark Release is made under and governed by the laws of the State of Illinois applicable to contracts made and to be performed entirely within such State, without regard to conflicts of laws principles.

6. This Trademark Release may be executed in any number of counterparts and delivered by facsimile or otherwise electronically, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same document.
