TERMINATION OF INTEREST IN TRADEMARKS

2. to the extent Lender shall be deemed to have any right, title or interest in the Borrower Trademarks, retransfers and reassigns to Borrower all of such right, title and interest without recourse and without representation or warranty of any kind whatsoever.

Lender hereby authorizes and requests that the Commissioner for Patents and Trademarks and any other governmental official record this Termination. This Termination shall be governed by the laws of the State of California.
