RELEASE OF TRADEMARKS

This RELEASE OF TRADEMARKS is dated as of June 12, 2015, by GENERAL ELECTRIC CAPITAL CORPORATION (successor-by-assignment to Wells Fargo Bank, National Association), as administrative agent (together with its successor(s) thereto in such capacity, the "Administrative Agent") for each of the lenders (as defined therein).

WHEREAS, Administrative Agent and Nice-Pak Products, Inc., a New York corporation ("Nice-Pak"), and Loan Parties party thereto (each an "Obligor" and together with Nice-Pak, the "Obligors") entered into that certain Term Loan and Security Agreement, dated as of June 18, 2007 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the "Loan and Security Agreement");

WHEREAS, the Loan and Security Agreement granted Administrative Agent a security interest in, among other things, certain trademarks, tradenames, trademark registrations, service marks, trade styles, terms, designs and trademark applications ("Trademarks"), including, without limitation, the Trademarks listed on Schedule I attached hereto as security for certain obligations of Obligors to Administrative Agent (the "Obligations");

WHEREAS, in connection with the Loan and Security Agreement, Administrative Agent and Obligors entered into that certain Assignment of Security Interest in Trademarks, dated as of May 9, 2012, that certain Notice of Grant of Security Interest in Trademarks, dated as of July 18, 2012 (the "First Notice") and that certain Notice of Grant of Security Interest in Trademarks, dated as of June 11, 2014 (the "Second Notice");

WHEREAS, Administrative Agent recorded the Assignment of Security Interest in Trademarks on May 9, 2012 at Reel 4775, Frame 0878 in the United States Patent and Trademark Office, the First Notice on July 24, 2012 at Reel 004827, Frame 0891 and the Second Notice on June 11, 2014 at Reel 5300, Frame 0545;

WHEREAS, Obligors have satisfied all of the Obligations and has requested that Administrative Agent release its security interests in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby agrees as follows:

Administrative Agent hereby fully releases and terminates its security interests in and liens on the Trademarks, including:

(a) all of Obligors' now existing or hereafter acquired right, title and interest in and to: all Trademarks which are now filed with the U.S. Patent and Trademark Office, any similar office or agency of any state, territory or possession of the United States or Canada or any similar office or agency of any other country or used in the United States, any state, territory or possession thereof including, without limitation, Puerto Rico, or any other country, and (i) any renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof,

(iii) the right to sue for past, present and future infringements thereof, (iv) all documents, packages, prints and labels on which said Trademarks have appeared and all designs and general intangibles of a like nature, and (v) all rights corresponding thereto throughout the world;

(b) the goodwill of Obligors' business connected with or symbolized by Trademarks; and


(c) any and all of the proceeds of any of the foregoing, including, without limitation, any claims by Obligors against third parties for infringement of the Trademarks or of any license with respect thereto.

Administrative Agent further agrees, at the sole cost and expense of Obligors, to perform all acts reasonably requested by Obligors to effect the release and termination of its security interests and liens in the Trademarks.
