**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK
COLLATERAL**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is made as of June 11, 2015 ("Effective Date"), by **EXPERIAN HOLDINGS, INC.**, a Delaware corporation ("Experian"), in its capacity as a secured party (together with its successors in such capacity, "Grantee"), in favor of **PG USA, LLC**, a Delaware limited liability company (the "Grantor").

WHEREAS, reference is made to that certain Security Agreement, dated as of October 22, 2012 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement"), by Grantor in favor of Grantee;

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of October 22, 2012, by and among Grantor, LowerMyBills, Inc., a Delaware corporation, LIM Holdings, LLC, a Delaware limited liability company, and LMB Mortgage Services, Inc. (collectively the "Debtors"), and Grantee, which was recorded with the United States Patent and Trademark Office on October 30, 2012 at Reel 4891, Frame 0044 (the "Trademark Security Agreement"), the Debtors granted to Grantee a security interest in all of the Debtors' right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement); and

WHEREAS, Grantee now desires to release its security interest in the portion of the Trademark Collateral that was granted to Grantee by the Grantor, including, without limitation, the trademark registrations and applications listed on Schedule 1 hereto (the "Grantor's Trademark Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its security interest in the Grantor's Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to Grantors all right, title, and interest of Grantee in the Grantor's Trademark Collateral.

Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantors' expense, as may be reasonably necessary to effect the release of the security interest in the Grantor's Trademark Collateral contemplated hereby. For the avoidance of doubt, at the request of Grantor, Grantee shall take all steps and execute and deliver all documents necessary to transfer to, PG USA, LLC all trademarks herein, whether listed as being owned by PriceGrabber.com, Inc., or PriceGrabber.com, LLC.
