
CERTIFICATE OF CONVERSION

1. The name of the corporation making the election to convert to a limited liability company pursuant to Official Code of Georgia Annotated (O.C.G.A.) Section 14-11-212 is Python Safety, Inc. (the "Corporation"), and such Corporation is organized under the laws of the State of Georgia.
2. The Corporation hereby elects to become a limited liability company.
3. The name of the limited liability company (the "Limited Liability Company") to be formed pursuant to this election is Python Safety, LLC.
4. This election and the conversion of the Corporation into the Limited Liability Company shall be effective upon the filing of this Certificate of Conversion; provided however, that for tax and accounting purposes such conversion will be deemed to become effective at 12:01 a.m. Eastern time on May 1, 2015.
5. The board of directors and sole shareholder of the Corporation have approved a plan of conversion and this election in accordance with O.C.G.A. Sections 14-11-212(a) and 14-2-1109.1(d).

Filed with this Certificate of Conversion are Articles of Organization for the Limited Liability Company that are in the form required by O.C.G.A. 14-11-204, that set forth a name for the Limited Liability Company that satisfies the requirements of O.C.G.A. Section 14-11-207, and that shall be the Articles of Organization of the Limited Liability Company formed pursuant to this election unless and until modified in accordance with the Georgia Limited Liability Company Act.
7. As a result of this election, each share of common stock of the Corporation will be converted into one unit of membership interest of the Limited Liability Company.


