NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS

June 3, 2015

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights, dated as of December 8, 2011, by Village Pantry, LLC, an Indiana limited liability company (the "Grantor"), in favor of VP C-Store Finance Holding, LLC, a Delaware limited liability company ("Lender"), recorded in the United States Patent and Trademark Office on January 26, 2009, 2008 at Reel 3924 / Frame 0464 (the "Agreement"; capitalized terms used but not otherwise defined herein shall have the meanings assigned to such terms in the Agreement), Grantor pledged and granted to Lender, a security interest in all of its right, title and interest in, to and under the Trademarks, including, without limitation, the registrations and/or applications listed on Schedule A hereto (the "Trademark Collateral");

WHEREAS, Grantor has requested that Lender (a) terminate and release the liens and interests of Lender in the Trademark Collateral and (b) provide a document suitable for recording in the United States Patent and Trademark Office for the release, relinquishment and discharge of its security interest in the Trademark Collateral;

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release Lender's security interest in the Trademark Collateral, and the parties seek to make record of Lender's release to Grantor of any and all of its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, (i) Lender did and hereby does relinquish, release and discharge its security interest in the Trademark Collateral, (ii) Lender hereby authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given and (iii) Lender hereby agrees to duly execute, acknowledge, procure and deliver, at the sole expense of Grantor or its successors and assigns, any further documents and to do such other acts as may be reasonably necessary to effect the termination, release, discharge or reassignment to Grantor of the security interest contemplated hereby.

This Notice of Release of Security Interest in Trademarks shall be governed by, and construed in accordance with, the laws of the State of New York.
