THIS DEED OF ASSIGNMENT is made the 22nd day of April 2015

BETWEEN

- (1) **THOMAS COOK UK LIMITED** of The Thomas Cook Business Park, Coningsby Road, Peterborough PE3 8SB, United Kingdom (the "Assignor"); and
- (2) **THOMAS COOK GROUP PLC** of 3rd Floor, South Building 200 Aldersgate, London EC1A 4HD, United Kingdom (the "Assignee").

1. INTRODUCTION

- 1.1 The Assignor was the proprietor and beneficial owner of the United States trade mark registrations detailed in the Schedule to this Deed (the "Trade Marks").
- 1.2 The Assignor has assigned the Trade Marks to the Assignee and the parties now wish to enter into this confirmatory assignment for the purposes of recording the assignment of the Trade Marks.

2. CONFIRMATION OF ASSIGNMENT OF TRADE MARKS



- 2.1 Under the Assignment of trademarks, domain names and unregistered rights in the "Thomas Cook" marks and Related Agreements between the Assignor and the Assignee entered into on 30 September 2013, and for the consideration specified therein, the Assignor assigned to the Assignee with full title guarantee all right title and interest in and to the Trade Marks, including all statutory and common law rights attaching to the Trade Marks and the right to take action in respect of past infringements of the Trade Marks and to retain any damages obtained as a result of such action.
- 2.2 The Assignor confirms that the assignment of the Trade Marks was made with the goodwill attaching to the Trade Marks and the goodwill of the business in which the Trade Marks have been used by the Assignor.
- 2.3 The Assignor shall at the request and expense of the Assignee do all acts and execute all documents in order to vest the Trade Marks in the Assignee.

3. LAW & JURISDICTION



This Deed shall be governed by and construed in accordance with English law and the parties submit to the non-exclusive jurisdiction of the English courts.
