WHEREAS, Assignor and Assignee wish to transfer ownership of the Marks and dissolve the license relationship;

WHEREAS, Assignor and Assignee intend for manufacturing of the products provided under the Marks to continue at Assignor's facility, it is understood and agreed that all use of the Marks by Assignor shall inure to the benefit of Assignee.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does assign, transfer, grant and convey to Assignee all right, title and interest in or related to the Marks, together with the goodwill of the business symbolized by the Marks, along with the U.S. and Canadian registrations identified above, for Assignee to hold, for the benefit of itself, its successors and assigns.

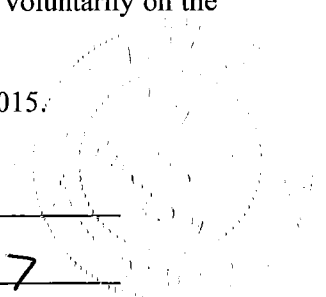
