We represent Healthcare Royalty Partners II, L.P., the current secured party with respect to the Trademark Security Agreement discussed below.

On November 7, 2011, a Trademark Security Agreement (the "Agreement") was entered between AcuFocus, Inc. ("AcuFocus") and Cowen Healthcare Royalty Partners II, L.P. ("Cowen"). AcuFocus granted a security interest in favor of Cowen to the Trademarks listed in the Agreement.

Cowen thereafter changed its name to Healthcare Royalty Partners II, L.P. ("HRP").
