ASSIGNMENT

Assignor hereby grants, conveys, assigns, transfers and quitclaims to Assignee, by execution hereof, any and all of Assignor’s right, title, and interest in and to the HOLO-LENS Registration, together with that part of the goodwill of the business connected with, and symbolized by, Assignor’s use of the HOLO-LENS mark in connection with the services identified in U.S. Reg. No. 4,276,092, the right to sue and recover for past infringements thereof, the right and interest in and to any and all proceeds therefrom, and the right to assign and transfer any rights and interests thereto.

This Assignment is subject to the terms and conditions of that certain Confidential Settlement Agreement among Assignor and Assignee, dated June 8, 2015.
