BETWEEN

- (1) Wellstream International Limited (Company No. 04582101) whose registered office is at Wellstream House, Wincomblee Road, Walker Riverside, Newcastle Upon Tyne NE6 3PF ("Assignor")
- (2) GE Oil & Gas UK Limited (Company No. 01521132) whose registered office is at 2 High Street, Nailsea, Bristol, BS48 1BS ("Assignee")

BACKGROUND

The Assignor is the proprietor of the Trade Marks. The Assignor has agreed to assign to the Assignee (and the Assignee has agreed to accept an assignment of) all of Assignor's right title and interest in and to the Trade Marks on the terms set out in this Assignment.

OPERATIVE PROVISIONS

- 1. In this Assignment the following expressions have the following meanings:
 - "Trade Marks" the registered trade marks and the applications set out in Schedule 1
- 2. In consideration of the sum of £1 the receipt and sufficiency of which is expressly acknowledged by the Assignor the Assignor hereby assigns to the Assignee all its worldwide right, title and interest in and to the Trade Marks, including without limitation:
 - 2.1 the absolute entitlement to any registered trade marks granted pursuant to any of the applications comprised in the Trade Marks; and
 - 2.2 all statutory and common law rights attaching to the Trade Marks, together with the goodwill of the business relating to the goods or services in respect of which the Trade Marks are registered or used; and
 - 2.3 all its rights and powers arising or accrued from the Trade Marks before, on, or after the date of this Assignment, including any right:
 - 2.3.1 to bring, make, oppose, defend, appeal proceedings, claims or actions; and
 - 2.3.2 to obtain relief (damages and other remedies) in respect of any infringement or alleged infringement, or any other cause of action (including passing off) arising from ownership of, all or any of rights in the Trade Marks, including (without limitation) any right to have the benefit of any relief obtained on such infringement before the date of this Assignment.
- 3. The Assignee accepts the assignment of the Trade Marks and all other rights assigned by

this Assignment.

4. The Assignor agrees that it will, at the Assignee's expense, promptly execute all documents, take all such actions and proceedings, do all things and provide all reasonable assistance to secure the right, title and interest in the Trade Marks and other rights assigned to the Assignee by this Assignment, including with limitation promptly executing and delivering all such lawful and necessary deeds and power of attorneys to enable recordal of the Assignee as the owner of the Trade Marks and other rights assigned to the Assignee by this Assignment
5. The rights transferred by this Assignment and the benefits of this Assignment will be enforceable by the Assignee together with any successor(s) in title or assignee(s).
6. This Assignment and any non-contractual obligations arising out of or in connection with it shall be governed by and construed in accordance with the laws of England.
7. The courts of England and Wales will have non-exclusive jurisdiction to settle disputes which may arise out of or in connection with this Assignment.
