CERTIFICATE OF INCORPORATION**

OF

Propel Biofuels, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

1. This Certificate of Amendment amends the provisions of the Corporation's Eighth Amended and Restated Certificate of Incorporation filed with the Secretary of State on November 25, 2014 (the "Certificate of Incorporation").
