The Assignor hereby binds itself, its heirs, legal representatives, administrators and assigns properly to cooperate at at the reasonable cost of the Assignee in the Assignee's

recordation of title, maintenance, and protection of the Servicemarks, and to execute, without any further consideration or remuneration, any and all applications, petitions, oaths and assignments or other papers and instruments which may be necessary in order to carry into full force and effect the sale, assignment, transfer and conveyance hereby made or intended to be made, and to communicate to said Assignee or its representatives and assigns all facts known to the undersigned respecting the Servicemarks, whenever reasonably requested, and to at at the reasonable cost of the Assignee testify in any interference proceeding or other legal proceedings in which the Servicemarks or any other servicemark which may issue on said applications may become involved.

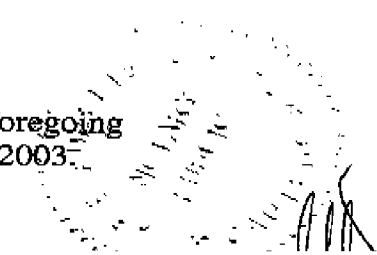



**DEED OF ASSIGNMENT OF
UNITED STATES OF AMERICA ("USA") INTELLECTUAL PROPERTY**

DATED 16 July 2003

PARTIES

- (1) **HERITAGE GROUP LIMITED BVI** a company registered in the British Virgin Islands under number 1702 and whose registered office is at c/o First Floor, Bank of Nova Scotia Building, Wickhams Cay, Road Town, Tortola, British Virgin Islands (the "Assignor");
- (2) **TREK AMERICA TRAVEL LIMITED** (registered no 04803471) whose registered office is at First Choice House, London Road, Crawley, West Sussex RH10 9GX (the "Assignee").

RECITALS

- (A) The Assignor is the owner of the Heritage USA Intellectual Property as defined in an agreement dated today between (1) Trek International Travel Limited (2) the Assignor (3) the Assignee and (4) First Choice Holidays plc (the "Asset Purchase Agreement") and as specified in the Schedule to this Deed.
- (B) By the Asset Purchase Agreement the Assignor has agreed to assign if requested to do so the Heritage USA Intellectual Property to the Assignee.

OPERATIVE PART

1. DEFINITIONS

- 1.1 Unless the context otherwise requires, terms defined in the Asset Purchase Agreement shall have the same meaning in this Deed.



2. ASSIGNMENT

- 2.1 In pursuance of the Asset Purchase Agreement and in consideration of the execution of this document as a deed the Assignor hereby assigns to the Assignee all the Heritage USA Intellectual Property with full title guarantee **TO HOLD** the same absolutely unto the Assignee.
- 2.2 The Assignor shall, and shall use its reasonable endeavours to procure that any necessary third parties shall, at the reasonable cost of the Assignee, do, execute and perform all such further deeds, documents, assurances, acts and things as the Assignee may reasonably require by notice in writing to the Assignor to carry the provisions of this Deed into full force and effect.

3. GENERAL

- 3.1 The provisions of the Asset Purchase Agreement relating to Notices shall apply to this Deed.
- 3.2 The provisions of the Asset Purchase Agreement relating to Costs shall apply to this Deed.
- 3.3 The provisions of the Asset Purchase Agreement relating to Assignment shall apply to this Deed.
- 3.4 The provisions of the Asset Purchase Agreement relating to Variation, Waiver and Severability shall apply to this Deed.
- 3.5 The provisions of the Asset Purchase Agreement relating to Law shall apply to this Deed.
- 3.6 The provisions of the Asset Purchase Agreement relating to Counterparts shall apply to this Deed.
- 3.7 The provisions of the Asset Purchase Agreement relating to Third Party Rights shall apply to this Deed.
