2. All Proceeds, as that term is defined in Section 1.01 of the Agreement, and rights of STP with respect to any and all of the Collateral included in paragraph 1 above.
3. Any and all other Collateral, as that term is defined in Section 1.01 of the Agreement, consisting of documents of STP evidencing any and all of the Collateral included in paragraphs 1 through 2 above.
