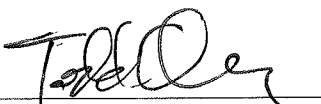

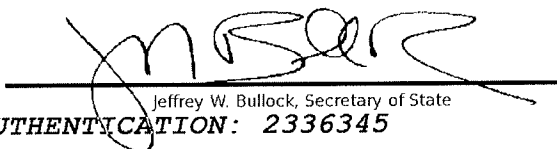

FOURTH: That the merger is to become effective at 3:02 a.m. Eastern time on September 1, 2012.

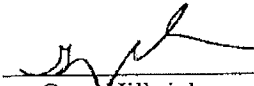
