RELEASE OF SECURITY INTEREST

WHEREAS, GuestHouse International, L.L.C., is a South Dakota limited liability company having a principal place of business at 415 N 4th St., Aberdeen, South Dakota 57402 ("GuestHouse"); and

WHEREAS, Capstar Bank, as successor to American Security Bank & Trust Company, a Tennessee corporation with a place of business at 101 Springhouse Court, Hendersonville, Tennessee 37075 ("Capstar"), is the holder of a "Security Agreement" dated December 1, 2006, and recorded in the United States Patent & Trademark Office on December 8, 2006, at microfilm reel #003440, frame #0684 (the "Security Agreement"); and

WHEREAS, Capstar desires to terminate the Security Agreement and to execute and deliver to GuestHouse all deeds, assignments and other instruments as may be reasonably necessary to revest in GuestHouse full title to the Collateral set forth in the Security Agreement.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Capstar hereby relinquishes unto GuestHouse the continuing security interest in and lien on the "Collateral" as defined in the Security Agreement, and otherwise assigns, grants and conveys to GuestHouse any and all rights Capstar may have in or to the Collateral of the Security Agreement in order to revest in GuestHouse full title to said Collateral.

Capstar hereby represents and warrants that it is the successor to American Security Bank & Trust Company, it has not assigned any interest in the Collateral and it has the unqualified right to enter into this release and perform its terms.

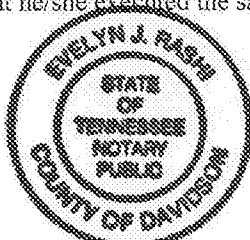
