**TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** ("Release") is executed as of June 19, 2015 by Ares Capital Corporation, as the successor Administrative Agent and Collateral Agent to Barclays Bank PLC ("Prior Agent") under and as defined in the Security Agreement (as defined below) (in such capacity as both the successor Administrative Agent and Collateral Agent, together with its successors and assigns, if any, the "Successor Agent"), in favor of GHS Interactive Security, LLC (the "Released Party").

WHEREAS, pursuant to the terms of that certain Pledge and Security Agreement and that certain Trademark Security Agreement, both dated May 3, 2013, both by and between the Released Party and the Prior Agent (the "Security Agreement") the latter as filed with the United States Patent and Trademark Office ("USPTO") on May 6, 2013 at Reel 5021, Frame 0764, the Released Party granted to Prior Agent a security interest in and continuing lien on the trademarks identified on Schedule A attached hereto;

WHEREAS, pursuant to the terms of that certain Assignment of Security Interest in Trademark Collateral Under the Trademark Security Agreement date May 30 2014 by and between Prior Agent and Successor Agent, as filed with the USPTO on September 5, 2014 at Reel 5357, Frame 0497, the Prior Agent assigned all of its rights, powers and privileges under the Security Agreement to Collateral Agent; and

WHEREAS, Successor Agent wishes to release the security interest in and continuing lien on the trademarks identified on Schedule A attached hereto (the "Trademark Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Successor Agent states as follows:

Successor Agent hereby terminates, releases, and discharges its security interest in and continuing lien on the Trademark Collateral under the Security Interest, and Successor Agent hereby assigns and transfers to the Released Party without recourse or representation or warranty, express or implied, of any kind, all of its right, title and interest in and to the Trademark Collateral together with the goodwill of the business symbolized thereby, including, without limitation, each of the applications, publications or grants identified on Schedule A attached hereto, effective as of the date set forth above.


Successor Agent understands and agrees that this Release may be recorded by or for the Released Party with the USPTO or any similar office or agency within or outside the United States.
