RELEASE OF SECURITY INTEREST

This RELEASE, dated as of June 19, 2015 is made by JPMORGAN CHASE BANK, N.A., a national banking association ("Lender"), with reference to that certain Pledge and Security Agreement, dated May 12, 2014, executed by PHOTOMEDEX, INC., a Nevada corporation, GATORADE ACQUISITION CORP., a Delaware corporation, RADIANCY, INC., a Delaware corporation, PHOTOMEDEX TECHNOLOGY, INC., a Delaware corporation, and LUMIERE, INC., a Nevada corporation ("Borrowers") in favor of Lender (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), which was recorded with the United States Patent and Trademark Office on May 14, 2014, at reel and frame number 5279/0775. 2. to the extent Lender shall be deemed to have any right, title or interest in the Borrower Trademarks, retransfers and reassigns to Borrowers all of such right, title and inters without representation or warranty of any kind whatsoever.

Lender hereby authorizes and requests that the Commissioner for Patents and Trademarks and any other governmental official record this Release. This Release shall be governed by the laws of the State of New York.
